#### Financial Report presented by Sam Seward, Treasurer

### Statement of Financial Position, Balance Sheet, June 30, 2016

- Current Assets this is report ending of our fiscal year and what our audit will be based off of
  - Cash position is similar to last year
  - Accounts receivable are up
  - Inventory is down just a bit
  - No changes in fixed assets
- Accounts payable is up a just a bit, and funds held for others up which is grants for agencies
- Assets are a 11.1 mil
- Fund Balance 10.831 which is down a bit part of which is decline in endowment account
  - o Endowments:

Intrust 1.486 down from 1.518 last year Baird 1.376 up from 1.326 last year

### Statement of Activities, from June 1 to June 30, 2016

- Over 4.370 mil in receipts
  - o Contributions are strong and up 106k over budget
- Disbursements:

- o Cost of food distributed is up as we are buying more food
- o Salaries are below expected as we were looking for new Director of Development
- Freight is over due to purchasing more food
- Rural Delivery is also up a bit
- $\circ$  Summer Food 75k in self pay and 48k in other
- In all, spent around 4.4 million bringing us to an \$80k loss.
  - Taking investment loss out of that, we are looking only at a \$30k loss for the year

# **Mobile Hygiene Pantry**

- Continues strong with 300 average households served
- Delta Dental will start providing dental kits for every MHP distribution in addition to dental kits for the F4K program

# PPIP-MPIN- Pounds Per Person In Poverty, Meals Per Person In Need

• Utilizing mobile pantries to bring counties into compliance

### **SNAP**

• GSNAP (internet online) applications count toward PPIP- Pounds Per Person in Poverty, measure for Feeding America compliance, in 85 county service area

### **BOB BOX**

• Averaging 425 boxes distributed in 44 counties per month

# CSFP –Commodity Supplemental Food Program

- Starting distribution in Lyon County this month with a goal of 140 participants
- This increase our reimbursable expenses for the program to \$17k per year

### Filling the Gap

- Operating 3 weeks this year, sites are serving an average of 800 per day
- Fugate donated \$12k to help cover third week of expenses

### **Amerigroup-Mobile Pantries**

- Running our second set of Mobile Pantries next week from the \$20k gift
- Feeding America staffers expected to join us on August 17th

### **Summer Feeding**

- Getting ready to wind down the USDA sites
- Doubled the number of meals we provided last year

- Brian met with Congresswoman Lynn Jenkins at a SFSP site in Fort Scott
- VISTA workers were instrumental in this program, would like 4 next summer

## Fugate Food 4 Kids Promotion

- Fugate promo ended this past week, we do not have figures yet
- Fugate will be presenting this weekend at the Food 4 Kids kick off at Dillons this coming Saturday, August 13

# **Empty Bowls**

- WSU Ceramics Guild puts this event on for the food bank, this will be the third year
  - Hoping to make this a signature event for the food bank raised \$17k last year
    - Will hold a "board day" this year for KFB board members to come make a bowl, more info to come on that

## Food 4 Kids

- Started getting product ready for the school year
- Expect numbers to be a bit lower this year due to school calendars changing and schools starting later in the year and ending earlier in the spring

# Need for new trailer and van

- Trailer estimated at \$80 \$100 k
  - Amerigroup has expressed interest in helping cover cost and we will tag and wrap with their logo for a specified amount of time
    - Expect to hear from them on mobile trip next week
- Refrigerated van is no longer running
  - Need to be replaced at cost of 34 35K
    - Used for QT pickups and small runs around town
      - This van was part of a Newman grant received in 2004 and has over 300,000 in town driving miles on it
