Financial Report presented by Sam Seward, Treasurer

## Statement of Financial Position, Balance Sheet, February 28, 2017

- Current Assets 7,074,862
  - Cash position is currently down \$375,000
  - Accounts receivable are up slightly
  - Inventory is about the same
  - Fixed assets are up
- Accounts payable is up by \$49,000
  - Funds held for others will be going down each month
- Assets are down \$100,000
- Fund Balance is down \$100,000
  - Due to investments not being included into cash as they are reinvested

## Statement of Activities, from April 1 to April 30, 2017

- Receipts are currently down \$410,000
- Contributions are down by about \$40,000
  - Brian stated all food banks are seeing a decline in contributions
- Disbursements:
  - Cost of food distributed is up

- Insurance is currently down
- Freight is down
- Food for Kids is up \$20,000 with about 3,000 additional children being helped
- Total Expenses are around 3.9 million leaving a fund balance of 45,320 for the year.

## President/CEO's Report presented by Brian Walker

## **Mobile Hygiene Pantry**

- Continues strong with 300 average households served
- Plans are to include High School Take Care program for high school students in need

## PPIP-MPIN- Pounds Per Person In Poverty, Meals Per Person In Need

- Utilizing mobile pantries to bring counties into compliance
  - Gray and Morris are out of compliance
  - Possible 20 counties out of compliance due to changes in MPIN standards

## **SNAP – Supplemental Nutrition Assistance Program**

• A VISTA worker along with staff are helping fill out the forms for individuals in need

#### **BOB BOX**

• Ellis and Russel on CSFP, it has went from 400 a month down to 300 a month served

## **CSFP** – Commodity Supplemental Food Program

• Currently serving 500 a month and need to get to 561 a month

### Filling the Gap

- With USDA ending in July, 17 sites will be ran in Wichita
- Working with Partners for Wichita
- The sites will be either ran for 4 weeks, 3 weeks or 2 weeks

### **Food 4 Kids**

- Made 197,000 packs of food for 398 schools serving 6,608 kids for the 2016-2017 school year
- Already in the works to get started back up again for the next school year

#### **Summer Feeding**

- 29 USDA sites currently being helped monitored by 4 VISTA workers
- Additional 11 self-pay sites who raise money on their own
- Received a \$20,000 grant from ConAgra via Feeding America to help

## **Capital Campaign**

• Constant progress and meetings with large donors, corporations and foundations

## **Independence Warehouse**

- Doing the budget as if the Independence warehouse isn't changing
- Will update as needed with the progress

## **Bruce Bartel Report**

- Attended the VOAD "Voluntary Organizations Active in Disaster" Conference
- Conference was geared for making disaster plans and building relationships with local government, agencies and other relief organizations
- Three year plan involving continuing training on relationship building and disaster plans which by year three will develop into possible grants into what is needed to make our own disaster plan or building better
